### OUR REQUIREMENTS

DNA to be supplied by the Customer as follows:

- Up to 94 samples per 96-well plate,
- DNA suitable for restriction enzyme digestion and ligation,
- Each sample about 20 ul of DNA in TE or other aqueous buffer at about 50 - 100 ng/ul,
- Fully skirted 96-well plate, closed with strips of 8 caps,
- Shipped to Us following the shipping instructions provided on the web site.

**Sample QC: Samples are checked for integrity, purity and concentration by running 1 ul of each sample on a 0.8% agarose gel, after incubation in digestion buffer for 1 hour.**

**The processing of samples supplied in non-standard plates or format will attract a surcharge.**

Time of Delivery of Results: Within 10 weeks of receiving suitable quality DNA in recommended plates
